Report on Cleaning and Disinfectant Chemical Exposures Associated with COVID-19.

Calls to U.S. poison centers about cleaner and disinfectant exposures increased by 20% (Jan – March 2020). Please click here for the MMWR.

The Ga AAP recommends reminding families to store hand sanitizer safely as the high alcohol content can be dangerous; these calls have also been increasing. The Chapter also wants to remind your families to save the poison control number in their phones and store cleaning supplies locked up or up and away and out of sight.

NOTICE OF PROPOSED RULEMAKING: Revision to Immunization of School Children Regulation 511-2-2-.02.

The purpose of the proposed rulemaking is to delay the implementation date of the requirement for a booster dose of meningococcal conjugate vaccine for eleventh grade students. Due to school closures and social distancing requirements imposed during the COVID-19 pandemic, the Department proposes to change the implementation date from July 1, 2020, to July 1, 2021. The GA AAP will meet with DPH, later this year, to determine if circumstances surrounding

COVID-19 change and a December 31, 2020 implementation date may be feasible.
