Announcements

New Chapter Committee on Diversity, Equity, and Inclusion Established - Last Thursday, the Executive Committee of the Georgia Chapter voted to approve the creation of a new committee on Diversity, Equity and Inclusion. This committee will be charged with the task of addressing the issues involving bias and discrimination at both organizational and patient care levels. U. S. Department of HHS Authorizes Pharmacists to Give Vaccines - Last week, the US Dept. of Health & Human Services issued an order that will permit pharmacists to give vaccines to children ages three years through 18 years if certain conditions are met. The Georgia Chapter has signed on to a letter from the Academy and AAP chapters to HHS Secretary Azar, calling on the Secretary to rescind this action and stressing the importance of children returning to pediatric practices for all needed preventive care.

Provider Relief Fund Update - Breaking news today: the deadline for applying for federal financial relief through the Medicaid and CHIP Provider Relief Fund portal has been extended to <u>September 13th</u>. Members are encouraged to visit the <u>HHS website</u> to apply for the Medicaid CHIP distribution.

In-office Testing for Covid-19: For questions about whether your office should be testing for Covid-19, whom to test, and proper PPE and cleaning procedures please refer to the recently released AAP testing guidance found here.

Currently, we understand that CPT code U0002 (Severity Acute Respiratory Syndrome [SARS-COV]) and CPT 87635 ("Infectious agent detection by nucleic acid (DNA or RNA); severe acute respiratory syndrome coronavrius 2 (SARS-CoV-2) (Coronavirus disease [COVID-19]), amplified probe technique.") are allowable per Medicaid. CPT code 87426 (infectious agent antigen detection by immunoassay technique of SARS-CoV and SARS-CoV-2) is not currently being accepted by Medicaid. For questions, email feskew@gaaap.org.

Cardiac Follow-up Recommendations for COVID-19 Positive Children - In last week's update, we noted that the American College of Cardiology published recommendations, "Returning To Play After Coronavirus Infection: Pediatric Cardiologists' Perspective", dated 7/14/2020. The article contains a suggested algorithm for approaching pediatric patients with a history of a COVID-19 infection who want to return to sports participation and physical activity. Census Deadline Now at September 30 - Please remind families to provide census information for their household which helps to ensure funding for Medicaid, CHIP, WIC, Head Start and other programs critical to the health and well-being of children.

In July, President Trump indicated that unauthorized immigrants should be excluded from the Census count. By law, the Census must count all persons living in the U.S., both citizens and non-citizens. You can reassure families that the Census will not ask about their citizenship status and Census information cannot be used to identify undocumented immigrants.

16th Annual Break the Cycle of Children's Environmental Health Disparities Training Program - Break the Cycle supports an interdisciplinary set of student-driven research projects that explore the environmental, economic, and social factors that adversely affect children's health. Students work with academic mentors from their universities to develop and submit a research proposal. If selected, they get to work with Break the Cycle faculty to complete and present their research results at an annual conference in Atlanta, Spring 2021. For more information, click here.
