

New CPT Code Approved for Use During Pandemic - This new code, 99072, can be reported for "additional supplies, materials, and preparation time required and provided by the physician or other qualified health care professional and/or clinical staff over and above those usually included in an office visit or other service(s), when performed during a nationally declared public health emergency due to respiratory transmitted infectious disease". "Open Notes Rule" Becomes Effective Nov. 2 - This new federal rule requires patients be provided access to all the health information in their electronic medical records without charge by their healthcare provider beginning November 2, 2020. Because of Covid-19, regulators have announced a three month period of "discretion" after the initial compliance date, which would make the Rule enforceable by February 1, 2021. AAP Announces Telehealth Stipends for Rural Practices - AAP is launching a program that will provide stipends to practices serving pediatric patients and families. The stipend program will offer \$5,000 to community-based practices that serve rural areas (with an emphasis on underserved populations in those areas) and are new to telehealth implementation. New Provider Relief Funding Phase 3 -- General Distribution - The U.S. Department of Health and Human Services (HHS) announced a next phase of provider relief funding. It will distribute \$20 billion to pediatricians and other providers who have experienced lost revenue and increased expenses due to COVID-19. Providers can apply from October 5 to November 6. October is Safe Sleep Month - Each year in the U.S., more than 3,700 infants, without a prior known illness or injury, die suddenly and unexpectedly from sleep-related causes such as SIDS and Accidental Suffocation and Strangulation in Bed. As of 2018, Georgia averaged three infant deaths per week due to sleep-related causes, which are mostly preventable.
